REMARKS:

Courier service and customs clearance excluded. SECA surcharge included.

Rolling H&H cargo, both new and used: self-propelled and self-driveable and in good working order. Units not designed to be selfpropelledor self-driveable, i.e. trailers, are exempt from the self-propelled / self-driveable conditions. However any braking systems must be in good working order.

No towed items are acceptable unless previously agreed. This includes trailers, boats, non-running rolling units, etc.

Shipping Lines reserve the right to refuse shipment of any units that have had their dimensions and/or weight inaccurately reported.

Shipper is responsible for all costs involved with fixing the unit, extra load/discharge costs and transport back to the original port of loading/discharge.

We recommend that written operational instructions for the unit are placed close to the driving position, to ensure correct operation by the stevedores.

The vehicles must be free of any personal effects, spare parts, used tyres or other undeclared/un-manifested items within them.

Vehicles may be rejected if such items are present.

Vehicles must have enough fuel to be loaded/discharged and move in the loading/discharge terminal. Vehicles running out of fuel are no longer self-propelled and will be rejected for shipment, or if already loaded, then the shipper becomes liable for all costs incurred to discharge the unit.
